In recognition of the need to encourage primary and continuing education for individuals belonging to the Northern California Chapter of the Appraisal Institute, the Chapter is pleased to continue to offer an Education Scholarship to assist Commercial (General) Candidates for Designation. The purpose of the scholarship award is to help cover tuition expenses for Appraisal Institute coursework associated with pursuing an Appraisal Institute Designation.

Preference in awarding the scholarships will be given to recipients specializing in commercial (general) real estate rather than residential. Furthermore, while any General Candidate for Designation is encouraged to apply, preference will be given to those actively pursuing the MAI designation. The scholarship is awarded and administered at the sole discretion of the Northern California Chapter.

Award checks will be presented to the scholarship recipients in the 1st quarter of 2024.

The Northern California Chapter of the Appraisal Institute reserves the sole right to choose the award recipient(s). Award decisions cannot be appealed to national Appraisal Institute representatives. The Northern California Chapter also reserves the right to withhold recommendations for scholarships in any given year and the right to seek additional information from the applicant. Application material will be considered confidential. Application material will not be returned to the applicant.


